

## Wydown United Church Building Use Policy & Procedures

It is the policy of Wydown United Church (hereinafter “WUC”) to utilize its building and facilities to support its mission and vision, membership and related organizations, as well as selected not-for-profit organizations that meet the guidelines established by WUC. WUC’s priorities for building use are as follows:

1. Members or other events involving WUC’s ministries will always have priority.
  2. Events sponsored by WUC members will have second priority.
  3. Requests for usage of WUC’s facilities by those outside of WUC membership will be given consideration as third priority.

The group liaison shall take personal responsibility or be authorized by the organization to sign the Facility Usage Agreement and assume any and all liability for any damage to the church or its property arising from the event. The appointed liaison shall also assume responsibility for the security of premises and appropriate handling of keys, as noted in the agreement.

Users of WUC facilities agree to use the utmost care in the use of the facilities and building, and agree to leave Wydown United Church in good, clean condition with lights turned off and doors securely shut and locked.

Users understand that, should a conflict develop in scheduled usage of WUC facilities, a group or organization may be required to move to a different room or cancel usage of the facilities.

### **GENERAL USER RESPONSIBILITY**

1. In the event of damage to WUC facilities, those responsible shall accept the amount of repair and replacement costs as designated by WUC.
  2. For children and youth events, the group or organization using the facilities must provide adequate adult supervision.
  3. Transfer of permission from any group or organization to another to use WUC facilities is strictly prohibited.

4. Those using WUC facilities must confine their activities to the area (or areas) noted in their Facilities Usage Agreement and will not exceed the capacity limits of the requested areas.
5. No furniture or equipment may be moved without WUC's knowledge and permission. No musical equipment may be used or moved without the consent of WUC's Minister of Music.
6. Use of alcoholic beverages is prohibited, except with the written approval of the WUC Executive Committee, and if approved, may be subject to conditions set by the Executive Committee. These conditions may include, without limitation, a requirement that the user provide evidence of alcohol liability insurance naming WUC as an insured. Use of tobacco products inside the church building is prohibited. Use or possession of scheduled drugs or firearms anywhere on the church premises is prohibited.
7. No group or organization (whether or not a member of WUC is affiliated with such organization) shall use any WUC facilities in any manner that conflicts or contradicts the mission or principles of Wydown United Church, law, regulation or local ordinance.
8. WUC's name shall not be used by any group or organization in any manner in advertising or other publicity or any other statements (oral or written) that indicate or imply that Wydown United Church endorses or sanctions the group, organization, event, mission or principles, except for any references to WUC as the location of the applicable event.
9. WUC reserves the right to deny access to political groups or political events, including fund-raisers for political causes or campaigns, except with the written approval of the WUC Executive Committee.
10. WUC reserves the right to modify, change or terminate these or any other WUC facility usage policies in whole or in part.
